Primary and Specialty Medical Care

We offer traditional primary care and specialty care in both an office clinical setting and online web-visit format. Specialty care includes allergy and immunology, gastroenterology, gynecology, and weight management. Our practice uses a fully-implemented electronic health record system which affords patients, physicians, and hospitals online access to health information.

Weight Management

We provide a physician-monitored weight management program in an office clinical setting with online support, including weekly e-communication with enrolled patients. Our program includes options such as prescription medication, Very Low Calorie (VLC) diets, and bi-monthly health coaching workshops.

Diagnostic Testing

For the convenience of patients and immediate diagnostic evaluation, we provide in-office diagnostic imaging services, including echocardiograms, general and vascular ultrasounds, DEXA scan, and fundus photography. Additional testing includes nerve conduction screening studies, treadmills, urodynamic testing, pulmonary function tests, ankle-brachial index (ABI) testing, glaucoma screening, body fat analysis, and basal metabolic rate (BMR) testing.

Laboratory Testing

Our moderately complex CLIA certified, COLA accredited on-site laboratory and draw station provides routine lab testing and pre-employment drug screening.

Full-Service Medication Dispensary

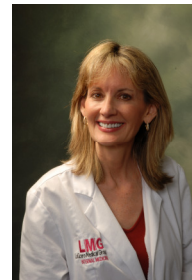
